19 of Mines, the Oklahoma Tourism and Recreation
20 Department, the Oklahoma Water Resources Board, the
21 Alcoholic Beverage Laws Enforcement Commission, the
22 Department of Corrections, the Oklahoma State Bureau
23 of Investigation, the Council on Law Enforcement
24 Education and Training, the Board of Medicolegal
Investigations, the Oklahoma State Bureau of
Narcotics and Dangerous Drugs Control, the Department
of Public Safety, the Court of Criminal Appeals,
district attorneys and the District Attorneys
Council, the Supreme Court, the Oklahoma Indigent
Defense System and the Pardon and Parole Board;
stating amounts of the appropriations; stating
purposes and restrictions; reappropriating and
redesignating certain funds; reappropriating certain
funds; authorizing transfers; and repealing Sections
1 through 169, Chapter 371, O.S.L. 2017, which relate
to general appropriations for the expenses of various
agencies of the executive, legislative and judicial
departments of the state.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 EDUCATION

2 SECTION 1. There is hereby appropriated to the Oklahoma
3 Education Lottery Trust Fund from any monies not otherwise
4 appropriated from the Special Cash Fund of the State Treasury, the
5 sum of Ten Million One Hundred Forty-four Thousand One Hundred
6 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
7 necessary pursuant to the provisions of subsection E of Section 713
8 of Title 3A of the Oklahoma Statutes.

9 SECTION 2. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2018, the sum of One Billion Thirty-six Million Four
13 Hundred Twenty-nine Thousand Four Hundred Thirty-seven Dollars
14 (\$1,036,429,437.00) or so much thereof as may be necessary for the
15 financial support of public schools.

16 SECTION 3. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Education Reform Revolving Fund created in Section 34.89 of Title 62
19 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
20 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
21 (\$695,407,138.00) or so much thereof as may be necessary for the
22 financial support of public schools.

23 SECTION 4. The State Board of Education is hereby authorized to
24 expend during the fiscal year ending June 30, 2018, from the Common

1 Education Technology Revolving Fund of the State Treasury, the sum
2 of Forty-seven Million Three Hundred Seventy-two Thousand Two
3 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
4 may be necessary for the financial support of public schools.

5 SECTION 5. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Mineral Leasing Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
9 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
10 necessary for the financial support of public schools.

11 SECTION 6. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Mineral Leasing Fund of the State Treasury for the fiscal year
14 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
15 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
16 may be necessary for the financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2018, the sum of Twenty-five Million
21 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars
22 (\$25,939,910.00) or so much thereof as may be necessary for the
23 financial support of public schools.

24

1 SECTION 8. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2016, the sum of Five Million Four
5 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars
6 (\$5,429,844.00) or so much thereof as may be necessary for the
7 financial support of public schools.

8 SECTION 9. Notwithstanding any other provision of law, the
9 State Board of Education is hereby authorized to expend during the
10 fiscal year ending June 30, 2018, from the School Consolidation
11 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
12 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
13 necessary for the financial support of public schools.

14 SECTION 10. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2018, the sum of Ninety-two Million Seventy-four
18 Thousand Thirty-three Dollars (\$92,074,033.00) or so much thereof as
19 may be necessary for the support of public schools activities.

20 SECTION 11. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
24 Three Hundred Twenty Thousand Three Hundred Forty Dollars

1 (\$299,320,340.00) or so much thereof as may be necessary for the
2 Certified Employee Health Benefit Allowance.

3 SECTION 12. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2018, the sum of One Hundred Sixty-three Million
7 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
8 (\$163,375,627.00) so much thereof as may be necessary for the
9 Support Personnel Health Benefit Allowance.

10 SECTION 13. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-
14 one Thousand One Hundred Five Dollars (\$15,681,105.00) or so much
15 thereof as may be necessary for administrative and support functions
16 of the State Department of Education.

17 SECTION 14. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2018, the sum of Two Million Eight
21 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
22 (\$2,882,213.00) or so much thereof as may be necessary for transfer
23 to the School Consolidation Assistance Fund.

24

1 SECTION 15. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2016, the sum of Six Hundred Three
5 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
6 thereof as may be necessary for transfer to the School Consolidation
7 Assistance Fund.

8 SECTION 16. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2018, the sum of Two Million Eight
12 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
13 (\$2,882,213.00) or so much thereof as may be necessary for transfer
14 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

15 SECTION 17. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2016, the sum of Six Hundred Three
19 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
20 thereof as may be necessary for transfer to the Teachers' Retirement
21 System Dedicated Revenue Revolving Fund.

22 SECTION 18. There is hereby appropriated to the Oklahoma Arts
23 Council from any monies not otherwise appropriated from the General
24 Revenue Fund of the State Treasury for the fiscal year ending June

1 30, 2018, the sum of Two Million Seven Hundred Twenty-seven Thousand
2 Forty-two Dollars (\$2,727,042.00) or so much thereof as may be
3 necessary to perform the duties imposed upon the Oklahoma Arts
4 Council by law.

5 SECTION 19. There is hereby appropriated to the State Board of
6 Career and Technology Education from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury for
8 the fiscal year ending June 30, 2018, the sum of One Hundred Five
9 Million Four Hundred Thirty-eight Thousand Six Hundred Seventy-seven
10 Dollars (\$105,438,677.00) or so much thereof as may be necessary to
11 perform the duties imposed upon the State Board of Career and
12 Technology Education by law.

13 SECTION 20. There is hereby appropriated to the State Board of
14 Career and Technology Education from any monies not otherwise
15 appropriated from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2018, the sum of
17 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
18 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection F of
19 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
20 the State Board of Career and Technology Education for the education
21 and general operating budgets of the institutions and for other
22 programs, construction, renovations or repairs administered by the
23 State Board of Career and Technology Education.

24

1 SECTION 21. There is hereby appropriated to the State Board of
2 Career and Technology Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2016, the sum of
5 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars
6 (\$663,648.00) pursuant to paragraph 2 of subsection F of Section 713
7 of Title 3A of the Oklahoma Statutes for allocation by the State
8 Board of Career and Technology Education for the education and
9 general operating budgets of the institutions and for other
10 programs, construction, renovations or repairs administered by the
11 State Board of Career and Technology Education.

12 SECTION 22. Notwithstanding any other provision of law, the
13 State Board of Career and Technology Education is hereby authorized
14 to expend during the fiscal year ending June 30, 2018, from the
15 State Board of Career and Technology Education Revolving Fund (200
16 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
17 much thereof as may be necessary to perform the duties imposed upon
18 the State Board of Career and Technology Education by law.

19 SECTION 23. There is hereby appropriated to the Office of
20 Educational Quality and Accountability from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2018, the sum of One Million Ninety-
23 two Thousand Five Hundred Ninety-nine Dollars (\$1,092,599.00) or so
24

1 much thereof as may be necessary to perform the duties imposed upon
2 the Office of Educational Quality and Accountability by law.

3 SECTION 24. There is hereby appropriated to the Office of
4 Educational Quality and Accountability from any monies not otherwise
5 appropriated from the Special Cash Fund of the State Treasury the
6 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
7 thereof as may be necessary to perform the duties imposed upon the
8 Office of Educational Quality and Accountability by law.

9 SECTION 25. There is hereby appropriated to the Oklahoma
10 Educational Television Authority from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2018, the sum of Two Million Six
13 Hundred Thirty-four Thousand One Hundred Eleven Dollars
14 (\$2,634,111.00) or so much thereof as may be necessary to perform
15 the duties imposed upon the Oklahoma Educational Television
16 Authority by law.

17 SECTION 26. There is hereby appropriated to the Oklahoma State
18 Regents for Higher Education from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2018, the sum of Six Hundred Twenty-
21 nine Million Four Hundred Sixty-three Thousand Five Hundred Six
22 Dollars (\$629,463,506.00) or so much thereof as may be necessary for
23 allocation by the Oklahoma State Regents for Higher Education
24 pursuant to the provisions of Article XIII-A of the Oklahoma

1 Constitution for the education and general operating budgets of the
2 institutions and for other programs, construction, renovations or
3 repairs administered by the Oklahoma State Regents for Higher
4 Education. Of those funds appropriated, the sum of Three Million
5 Thirteen Thousand One Hundred Thirty-nine Dollars (\$3,013,139.00)
6 shall be transferred to the Oklahoma Tuition Equalization Grant
7 Trust Fund to implement the provisions of the Oklahoma Tuition
8 Equalization Grant Act.

9 SECTION 27. The Oklahoma State Regents for Higher Education are
10 hereby authorized to expend during the fiscal year ending June 30,
11 2018, the sum of Forty-seven Million Three Hundred Seventy-two
12 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
13 Higher Education Capital Revolving Fund of the State Treasury for
14 allocation by the Oklahoma State Regents for Higher Education
15 pursuant to the provisions of Article XIII-A of the Oklahoma
16 Constitution for the education and general operating budgets of the
17 institutions and for other programs, construction, renovations or
18 repairs administered by the Oklahoma State Regents for Higher
19 Education.

20 SECTION 28. The Oklahoma State Regents for Higher Education are
21 hereby authorized to expend during the fiscal year ending June 30,
22 2018, the sum of Forty-seven Million Three Hundred Seventy-two
23 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
24 Oklahoma Student Aid Revolving Fund of the State Treasury for

1 allocation by the Oklahoma State Regents for Higher Education
2 pursuant to the provisions of Article XIII-A of the Oklahoma
3 Constitution for the education and general operating budgets of the
4 institutions and for other programs, construction, renovations or
5 repairs administered by the Oklahoma State Regents for Higher
6 Education.

7 SECTION 29. There is hereby appropriated to the Oklahoma State
8 Regents for Higher Education from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2018, the sum Nine Hundred Forty-
11 five Thousand Eighty-seven Dollars (\$945,087.00) or so much thereof
12 as may be necessary for expenditures for concurrent enrollment
13 pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

14 SECTION 30. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the Oklahoma Education Lottery Trust Fund of the
17 State Treasury for the fiscal year ending June 30, 2018, the sum of
18 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred
19 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of
20 subsection F of Section 713 of Title 3A of the Oklahoma Statutes for
21 allocation by the Oklahoma State Regents for Higher Education
22 pursuant to the provisions of Article XIII-A of the Oklahoma
23 Constitution for construction, renovations or repairs administered
24 by the Oklahoma State Regents for Higher Education or for any other

1 purpose authorized by paragraph 2 of subsection F of Section 713 of
2 Title 3A of the Oklahoma Statutes.

3 SECTION 31. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2016, the sum of
7 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
8 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
9 F of Section 713 of Title 3A of the Oklahoma Statutes for allocation
10 by the Oklahoma State Regents for Higher Education pursuant to the
11 provisions of Article XIII-A of the Oklahoma Constitution for
12 construction, renovations or repairs administered by the Oklahoma
13 State Regents for Higher Education or for any other purpose
14 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
15 of the Oklahoma Statutes.

16 SECTION 32. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2018, the sum of Three Million Five
20 Hundred Sixty-six Thousand Four Hundred Ninety-one Dollars
21 (\$3,566,491.00) or so much thereof as may be necessary for the
22 general operating budget of the Administrative Offices of the
23 Oklahoma State Regents for Higher Education.

24

1 SECTION 33. There is hereby appropriated to the Commissioners
2 of the Land Office from any monies not otherwise appropriated from
3 the Commissioners of the Land Office Fund of the State Treasury for
4 the fiscal year ending June 30, 2018, the sum of Eight Million Five
5 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
6 so much thereof as may be necessary to perform the duties imposed
7 upon the Commissioners of the Land Office by law.

8 SECTION 34. There is hereby appropriated to the Oklahoma
9 Department of Libraries from any monies not otherwise appropriated
10 from the General Revenue Fund of the State Treasury for the fiscal
11 year ending June 30, 2018, the sum of Four Million Two Hundred
12 Seventy-nine Thousand Eight Hundred Forty-three Dollars
13 (\$4,279,843.00) or so much thereof as may be necessary to perform
14 the duties imposed upon the Oklahoma Department of Libraries by law.

15 SECTION 35. There is hereby appropriated to the Physician
16 Manpower Training Commission from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2018, the sum of Two Million Eight
19 Hundred Thirty-four Thousand Thirty-four Dollars (\$2,834,034.00) or
20 so much thereof as may be necessary to perform the duties imposed
21 upon the Physician Manpower Training Commission by law.

22 SECTION 36. There is hereby appropriated to the Physician
23 Manpower Training Commission from any monies not otherwise
24 appropriated from the Special Cash Fund of the State Treasury the

1 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
2 thereof as may be necessary to perform the duties imposed upon the
3 Physician Manpower Training Commission by law.

4 SECTION 37. There is hereby appropriated to the Board of
5 Trustees of the Oklahoma School of Science and Mathematics from any
6 monies not otherwise appropriated from the General Revenue Fund of
7 the State Treasury for the fiscal year ending June 30, 2018, the sum
8 of Six Million One Hundred Twenty-one Thousand Seven Hundred Nine
9 Dollars (\$6,121,709.00) or so much thereof as may be necessary to
10 perform the duties imposed upon the Board of Trustees of the
11 Oklahoma School of Science and Mathematics by law.

12 SECTION 38. There is hereby appropriated to the Oklahoma Center
13 for the Advancement of Science and Technology from any monies not
14 otherwise appropriated from the General Revenue Fund of the State
15 Treasury for the fiscal year ending June 30, 2018, the sum of
16 Thirteen Million Ninety-five Thousand Six Hundred Eighty-one Dollars
17 (\$13,095,681.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the Oklahoma Center for the Advancement of
19 Science and Technology by law. Of those funds appropriated, the sum
20 of Five Million One Hundred Twenty Thousand Two Hundred Eighty
21 Dollars (\$5,120,280.00) shall be deposited in the Research Support
22 Revolving Fund, created pursuant to Section 5060.11 of Title 74 of
23 the Oklahoma Statutes. Of those funds appropriated, the sum of Two
24 Million Eight Hundred Sixteen Thousand One Hundred Fifty-four

1 Dollars (\$2,816,154.00) shall be deposited in the Seed-capital
2 Revolving Fund, created pursuant to Section 5060.21 of Title 74 of
3 the Oklahoma Statutes.

4 GENERAL GOVERNMENT AND TRANSPORTATION

5 SECTION 39. There is hereby appropriated to the Office of the
6 Attorney General from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Eight Million Nine Hundred Forty-
9 four Thousand Six Hundred Fifty Dollars (\$8,944,650.00) or so much
10 thereof as may be necessary to perform the duties imposed upon the
11 Office of the Attorney General by law.

12 SECTION 40. There is hereby appropriated to the Office of the
13 Attorney General from any monies not otherwise appropriated from the
14 General Revenue Fund of the State Treasury for the fiscal year
15 ending June 30, 2018, the sum of Nine Hundred Four Thousand Seven
16 Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal
17 Services Revolving Fund, created pursuant to subsection G of Section
18 921.1 of Title 12 of the Oklahoma Statutes.

19 SECTION 41. REAPPROPRIATION AND REDESIGNATION The amount
20 of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) of the
21 original appropriation of Five Million Dollars (\$5,000,000.00),
22 appropriated to the Office of the Attorney General by Section 154,
23 Chapter 311, O.S.L. 2012, from any monies not otherwise appropriated
24 from the Special Cash Fund of the State Treasury, for the

1 prosecution and defense of claims related to water and water rights
2 in Oklahoma, is hereby reappropriated and redesignated to perform
3 the duties imposed upon the Office of the Attorney General by law.
4 If, on the date this act is approved, any of the amount originally
5 appropriated, as adjusted by expenditures, encumbrances and
6 transfers, results in an unencumbered balance less than the
7 reappropriated and redesignated amount, that reappropriated and
8 redesignated amount is reduced to the unencumbered amount.
